I write in my capacity as District Commander for Chelmsford and Maldon to express my thanks for your support in continuing to develop partnership working within your school and to agreeing to take part in 'Project Enlightenment'.

There has been widespread local and national media publicity in relation to the criminal exploitation of children and the harm posed to them by county lines, gangs and organised crime, and keeping our children safe is a high priority for all of us.

I believe action to tackle child criminal exploitation should be proactive, focussing on prevention, early identification and intervention, as well as on disrupting activity and prosecuting perpetrators.


The purpose of the project is to help us work even more closely with schools in our area to help children and young people who may be at risk of criminal exploitation, by identifying potential risk early and taking proportionate steps to reduce any harm to them.

Your willingness to work alongside us creates a unique opportunity where this can be delivered in a safe setting and I am proud to be able to work with representatives from your school and others across Chelmsford and Maldon. We will be supported in this project by the respective community safety partnerships for Chelmsford and Maldon who are already providing interventions to tackle violence and vulnerability in the form of education sessions for students and parents/carers. The commitment from the partnership is mirrored in our strategic priorities of reducing violent crime, tackling anti-social behaviour and supporting vulnerable persons.

My position is that we all have an obligation to keeping children safe and I hope this project demonstrates my commitment to doing just that.
